Comparison

PinPoint's unique dynamic cube architecture distinguishes it from other OLAP applications in the market. Nearly all other applications require predefined cubes that limit the access within each dataset making it impossible to drilldown outside of the cube. PinPoint enables full access to the data through an optimized architecture that allows drilling anywhere securely and auickly. Other B.I. applications require multiple licenses and costly maintenance, but PinPoint is an integrated suite with single site license for unlimited use.
